

**BAY COUNTY CONSERVATION AND GUN CLUB**  
**MEMBER AND GUEST AGREEMENT**

1. I am a member of the Bay County Conservation and Gun Club (BCC&GC), or am present as a guest by my own free will. The privileges and benefits of membership or of my guest presence have been extended to me in exchange for certain payment and promises from me, including this Agreement.

2. I understand and acknowledge that there are inherent risks with the use of firearms and related equipment and with participation in shooting activities, and being in the proximity of others using firearms. I understand and acknowledge that the general and various activities of life entail certain risks.

3. While on BCC&GC property, I acknowledge that I am solely responsible for my actions, including without limitation, all acts, omissions, and failures to act. I accept all risks associated with the use of firearms, and being in the proximity of others using firearms, along with all risks of any nature in any way associated with my presence or activities on BCC&GC property. If I am a member, I acknowledge that I am responsible for any family members and minors that accompany me as a benefit of my membership and that the provisions of this Agreement extend to them. If I am a guest, I acknowledge that I am responsible for any minors that accompany me and that the provisions of this Agreement extend to them.

4. I acknowledge that I have received a copy of the Rules and Regulations of the BCC&GC and that it is my obligation to read, understand and comply with them, and to ensure that any minors who accompany me comply with those Rules and Regulations. My presence on BCC&GC property and participation in any activity there are contingent on my compliance with the Rules and Regulations.

5. If I am a member, I acknowledge that my violation of any rules or regulations may result in disciplinary action by the Board of Directors up to and including the revocation of my membership.

6. AS A CONDITION OF MY PRESENCE ON BCC&GC PROPERTY, I AGREE TO HOLD HARMLESS, INDEMNIFY, DEFEND AND COVENANT NOT TO SUE BCC&GC, ANY OF ITS OFFICERS, DIRECTORS, EMPLOYEES, AGENTS, OR MEMBERS (“INDEMNIFIED PARTIES”) FROM ANY ALLEGED CAUSE OF ACTION OR ALLEGED INJURY, DAMAGE, OR LOSS, WHETHER TO PERSON OR PROPERTY, OF ANY NATURE (INCLUDING BUT NOT LIMITED TO, PHYSICAL, EMOTIONAL, MENTAL, ECONOMIC, OR PAIN AND SUFFERING) ARISING AT ANY TIME WHICH IS IN ANY WAY RELATED TO MY PRESENCE ON BCC&GC PROPERTY, EXCEPT IN CASES WHERE THE KNOWING, WILLFUL AND WRONGFUL INFLICTION OF SERIOUS HARM BY THE INDEMNIFIED PARTIES IS FOUND TO BE THE DIRECT AND PROXIMATE CAUSE OF THE CLAIMED INJURY OR DAMAGE; IN SUCH AN INSTANCE, THIS AGREEMENT SHALL NOT PROTECT THAT SPECIFIC MEMBER OF THE INDEMNIFIED PARTIES WHO IS FOUND TO HAVE COMMITTED SUCH AN ACT.

7. If I, or any of my guests or family members, are novice shooters or inexperienced at any shooting sport in which we plan to participate, we must inform Club management before we shoot. The Club may require that an experienced Club member accompany us to ensure safety until such time as the Club is satisfied we have demonstrated an understanding of safe use of the course.

8. This Agreement binds me and my estate.
